Vendor Rules and Regulations

- Application Deadline:** Must be postmarked no later than July 4th, accompanied by this application, picture of booth, space fee and, for food booths, a copy of your health certification.
- Check-In and Set-Up:** Vendors can begin setting up their booths on Thursday, July 5th. All vehicles must be removed from the park by 5:30 pm on that Thursday. Booths must be open no later than 6:00 pm Friday, July 6th and 10:00 am Saturday, July 7th.
- Booth Sizes:** \$125.00 for a 10' x 10' space and \$200.00 for a 10' x 20' space.
- Items Not Allowed:** Water, soft drinks, throwing stars, martial art weapons, knives, brass knuckles, swords, drug paraphernalia, or any unlawful or lewd items.
Violators will be shut down.
- Booth Services:** Electricity will be supplied **FOR LIGHTS ONLY** (15 amp). Any additional power needed must be supplied by the vendor. The Freeport Host Lions Club will not be responsible for thrown breakers. This has been an issue in the past, and we do not have the man power to service breaker problems due to vendors using more power than what is supplied for lights. **Violators will be shut down.**
- Food/Craft Vendors:** Food vendors are limited to four major food items. Please list items you intend on selling on the application. Craft vendors must list the types of arts/crafts you will be selling.
- Clean-Up:** Vendors are responsible for their areas. All booth construction and debris must be removed. Booths must remain in the park until 1:00 am on Sunday, July 8th.
- Refunds:** There will be no refunds if the booth is canceled after **Wednesday June 27th**.
- Note:**
- Full payment is required with application by July 4th, to secure your space. (No payment agreements will be made.)
 - Each vendor is responsible for all sales tax, trash, signage, etc.
 - Food booths must have covers on their booths.
 - No vendor booth will be allowed to sell any type of soft drink or water. **NO EXCEPTIONS!!!**
 - Please enclose a picture of your booth with your application.

NOTE

We do not anticipate turning any applicant away, but in the event that there are an overwhelming number of applicants or like food/refreshment items, we reserve the right to limit booth participation and location.
